Wood and Historic Preservation

Ron Anthony, Wood Scientist for Anthony & Associates, Inc. will discuss Wood and Historic Preservation. The talk will address condition assessment, grading to determine allowable design stresses, and considerations when writing specifications for new construction and rehabilitation projects.

on Anthony, President and Wood Scientist for Anthony & Associates, received an M.S. in Wood Science and Technology from Colorado State University. Mr. Anthony's research activities have focused on nondestructive evaluation and materials testing to better understand how wood interacts with other materials and performs over time. His efforts have led to applications of resistance drilling and digital radioscopy for quantifying decay in structural timbers and investigating hidden conditions. His consulting activities have focused on the application of these innovative inspection technologies for assessment of wood in historic structures, including several mill buildings.

Mr. Anthony is the 2002 recipient of the James Marston Fitch Foundation Grant for his approach to evaluating wood in historic buildings.
