MAY GENERAL MEETING

ARCHITECTURALLY EXPOSED STRUCTURAL STEEL FOR ARCHITECTS AND ENGINEERS

Projects where the structure is expressed as a part of the finished product require the utmost coordination and cooperation between the Architect and Structural Engineer. That is why this month SEAC is encouraging all members to "bring their favorite Architect" along to the general membership meeting on May 9th. The program will present the guidelines of the SEAC Steel Liaison Committee regarding the use of Architecturally Exposed Structural Steel (AESS). These guidelines address the work required by both the Architect and Engineer in completing AESS projects.

The **SEAC Steel Committee** has met jointly with members of the **Rocky Mountain Steel Construction Association (RMSCA)** on a monthly basis since 1997. The membership of the committee represents Engineers, Fabricators, Detailers, and Erectors, offering a balanced discussion to the projects undertaken by the committee. The most recent project of the Steel Liaison Committee has been to prepare guidelines for the design and specification of AESS. A few of the questions on which the committee has focused are as follows:

- Is there a standard for the appearance of AESS structures?
- How can the details of the finish of the steel be effectively communicated to the Contractor?
- What cost premiums should be expected for steel specified as AESS?
- What issues regarding coatings and steel preparation should be addressed in the contract documents?

To answer these questions, the committee has met for the last 14 months and engaged the help of local Architects, AISC, and the coatings industry. The guidelines consist of three elements. First, the committee developed a sample board showing the range of finishes to be expected from local structural steel fabricators. A cost matrix that may be used as a guide for addressing the cost premiums associated with AESS will be presented. Finally, a master specification which can be edited for the specifics of a job will be distributed for your comment and use.

Please come join us for breakfast on May 9 and don't forget to bring your favorite Architect. In addition to learning something, this is a great opportunity to present SEAC to the architectural community of the Front Range. Guests will be \$10 at the door.

NEWSLETTER OF THE NATIONAL COUNCIL OF STRUCTURAL ENGINEERS ASSOCIATIONS

On January 19 and 20, 2002, the Board of Directors met in Tempe, Arizona for our winter board meeting. The board meeting was "piggy backed" on the Winter Institute that began on the afternoon of January 20th. There were also several committee meetings that met on January 18th. The following are some highlights of those meetings.

Committee Meetings

The first meeting of our Structural Engineering Emergency Response Plan (SEERP) Committee was held. This committee has been charged with putting together a guideline for structural engineers responding to a disaster. When finished this guideline will be distributed to our member organizations. The first meeting of our Certification Business Plan Committee was held. This committee has been charged with putting together a plan to operate a Certification Program should our members vote to establish Certification. The Certification Committee also met. This committee is in the final stages of developing a model certification program to present to the membership. The Editorial Board of STRUCTURE Magazine also met. This group is responsible for the editorial content of the magazine. **Board Meeting**

One of the Highlights of the board meeting was the introduction of the new publisher for STRUCTURE Magazine. Copper Creek Consulting Group from Reedsburg, Wisconsin is the new publisher. Christine Sloat, P.E. is the president of Copper Creek.

NCSEA's 2002 Annual Meeting will be held in Chicago, October 17-19, 2002. The Structural Engineers Association of Illinois will host the meeting.

Two members, Oregon and Colorado, have offered to host the 2003 Annual Meeting. The board is awaiting formal proposals to make a decision.

Ben Baer reported on the Winter Institute. This year's theme was "Learning From Our Mistakes, Failures, Forensics, Ethics and Risk". Attendance for the Institute was down about 20 percent from last year. Given the economy, this was not unusual; other conferences have experienced similar losses in attendance. The Location of the 2003 Winter Institute will probably be in the Tampa Bay area of Florida. No theme has been selected yet.

Fromy Rosenberg, AISC, spoke to the board about the AISC Partnering in Education Program.

A status report on the World Trade Center and Pentagon Building Performance Study Teams was presented to the board. Both teams are planning on issuing a report some time in March.

A report on the Leaders' Forum held in Seattle in December of 2001 was given to the Board, as was an update on the progress of the Certification Committee. Certification presentations are being given to Member Organizations around the country, to explain what certification is and what it is not.

Jim Delahay, from the Structural Engineers Association of Alabama, was named to replace Rawn Nelson as chair of NCSEA's Code Advisory Committee. Rawn is stepping down, after serving as chair since the creation of the Committee. Rawn has done a great job and the Code Advisory Committee has become the "go to" group when any questions arise on building codes.

Jim Delahay has also been reappointed as a member of the Board

of Directors of the Applied Technology Council (ATC). Three years ago, ATC created a board position to be filled by appointment from NCSEA. ATC was so pleased with Jim's work that they asked if he could be appointed to another three-year term.

John Tawresey, Chair of the SEI Board of Governors, reported on SEI activities.

Joe Gehlen from CASE reported on CASE activities.

Emile Troup reported to the Board on the status of NFPA 5000, Chapter 38 'Quality Assurance During Construction'. As currently proposed, Chapter 38 would mandate that the Responsible Design Professional (RDP) be responsible for the QA program. While most of the board members are in favor of more control of QA by the design professionals, many did not favor that it be code mandated. The NCSEA representatives on the NFPA Technical Committee developing Chapter 38 are aware of the Board's concerns.

Jon Schmidt, from the newly formed Kansas/ Missouri Structural Engineers Association, has agreed to represent NCSEA in The Infrastructure Security partnership (TISP). TISP is comprised of government agencies, professional associations, code and standard groups and industry trade groups. TISP's purpose is to facilitate dialogue on domestic infrastructure security, and to offer technical support and sources for expert comment on public policy related to the security of the nation's built environment.

Winter Institute

There were many highlights to this year's Winter Institute, a tribute to Ben Baer from the Structural Engineers Association of Illinois, who organized this event. This was NCSEA's third Winter Institute and Ben has organized all of them.

James Chiles gave a fascinating presentation about his book 'Inviting Disaster: Lessons from the Edge of Technology' published in September 2001 by Harper Collins. All attendees to the Institute were given a copy of the book. The book gives details and, surprisingly, the similarities of many notable disasters, from airplane crashes to Three Mile Island.

Jack Gillum, PE, structural engineer of record for the Kansas City Hyatt Hotel, gave a presentation titled 'A Personal Perspective on Structural Failures'.

Paul Lurie, a senior partner in the Chicago law firm of Schiff Hardin & Waite, discussed legal Issues, dispute resolution and standard of care.

Vivian Weil, PhD., Director of the Center for the Study of Ethics in the Professions and Professor of Ethics at the Illinois Institute of Technology, spoke on 'Ethics in Structural Engineering: Is There a right or Wrong'.

Mike Gorman, PE, President of the Structural Engineers Risk Management Council (SERMC), made two presentations on insurance claims.

The Board of Directors is currently trying to arrange a Structural Engineers Association of Colorado Night with the Colorado Rockies. Public awareness of what structural engineers do for our society is probably higher than it has been in a very long time.
