

In addition, for the first time in 2003, SEAC retained a part time Administrative Director, Ms. Caryn Bauer. The director's position is purely administrative to reduce the burden of work on the officers who work on a volunteer basis. Our General Meetings were well attended this year with the number of persons attending varying from around 60 to over 90 for the September meeting.

In addition to the education function that our meetings serve, SEAC took a lead role with AIA, ACEC, and CAGE (Colorado Association of Geotechnical Engineers) in financially supporting the appeal of the Dufficy vs. BRW judgement to the Colorado Supreme Court. In brief terms, the lower court ruled that an Engineer or Architect owes a duty of care to a Contractor to protect them from economic loss. The court has agreed to hear the case and it is moving forward this month.

Our Business Management Committee met regularly and conducted and distributed the annual Business Practice Survey. This committee is also active in reviewing and feeding information into the Standard of Practice Committee.

The Standard of Practice Committee became active this year with significant encouragement from the Board of Directors (BOD) and direction from a new chairman. The SEAC Standard of Practice document was last updated in 1987 and does not address issues such as the use of CAD files, design-build, and other recent trends. In addition, many areas of the document are outdated. The committee has established a monthly meeting schedule for the next year, and will present a fall half day seminar to the membership to unveil the updated document.

The Steel Committee has continued to meet on a nearly monthly basis. Their work on Architecturally Exposed Structural Steel has been picked up and endorsed by AISC this year. The entire work was published in the May issue of Modern Steel Construction, and parts of the presentation given to our members last year has been incorporated into AISC's education series for Architects. The committee has completed position papers on AISC Quality Certification program for fabricators, and on the OSHA subpart 'R' regulations. They are currently finishing a guide to define early packages issued for pricing, GMP, bid, permit, etc. and the level of completeness of the document that should be expected.

The AIA/SEAC Liaison Committee has become active after a three-year hiatus with a new chairman and strong urging from the BOD. The board is committed to increasing our communication with and support of the local architectural community. In addition to this committee, SEAC president has been attending the 'AIA Coordinating Organizations' meetings this year. This

group represents AIA, SEAC, ACEC, AGC, BOMA, as well as 20 other organizations dedicated to the development, design, construction, and operation of buildings. The goal of this group is to coordinate the calendar and programs of these organizations to eliminate overlap, schedule conflicts and duplication. The other stated goal is to provide a coordinated voice for all of these organizations on issues where we all hold a common view.

The SEERP Committee has been started and is chaired by two members with ties to the local FEMA Urban Search and Rescue team. In addition to meetings of the committee, the chairs have met with emergency officials from the City and County of Denver (CCD), the Governor's office and several local fire districts.

Finally, our Building Department Committee has had several joint meetings with the Denver Building Department to address amendments to the 2000 IBC which is up for adoption by the CCD. The committee also met with the city to review and develop a policy regarding two issues brought by SEAC members.
