Denver Building Department Liaison Committee (Chair: Jerry Maly)

As you probably know, the City and County of Denver will officially adopt the 2006 I-Codes, including the IBC with the Denver Amendments, on August 4, 2008. The 2009 I-Codes will be published early next year; however, at this time there is not yet a target date as to when they will be adopted by the City and County of Denver. The Denver Building Department Liaison Committee will begin meeting in the late winter/early spring of 2009 to review the 2009 IBC and to develop/prepare recommendations to the Denver Building Department for structural amendments to this code.

A sub-committee of the Denver Building Department Liaison Committee, chaired by Stan Welton (Martin/ Martin, Inc.), is working with the Community Planning and Development Agency to develop policies regarding City and County approval of Special Inspectors and approval of Quality Assurance Agencies.
